Part A: Pupil premium strategy plan

Statement of intent

Our pupil premium funding supports the achievements of children from disadvantaged backgrounds. Our aim is to close the attainment gap between disadvantaged pupils and their peers, in turn raising their attainment and impacting on their long-term goals and 'readiness' for the next stage in their education and throughout life.

We understand that no two pupils are the same and that no two disadvantaged pupils are the same, therefore our plan focuses on the needs of individual pupils as well as the achievements of all.

Our plan focusses on strategies to further develop and improve quality first teaching as well as provide bespoke, targeted support where needed. We know that high-quality teaching, across all subject areas, will have the greatest impact on all pupils, including disadvantaged pupils. We recognise the importance of continuing CPD for teachers and school staff to provide the highest quality education. Wider strategies to support with non-academic areas such as social and emotional support will also be of high priority as will supporting emotional wellbeing and mental health. We also support the wider curriculum, ensuring that all pupils are able to access extra-curricular activities as well as curriculum enhancements.

Our plan and the actions detailed below, will be based on thorough and robust diagnostic assessment leading to bespoke and high-quality provision as well as being adaptable and reactive, based on the needs of the pupils as they develop.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Limited aspiration which affects resilience and self-motivation. Monitoring indicates that some children struggle to remain resilient in the face of academic challenge and need additional support to build up their self-confidence and readiness to 'have a go' without fear of failure.
2	Language deficit - gap in vocabulary and lack of ability to use language effectively. Assessments, discussions with staff and monitoring show that some children have gaps in both their oral language skills and their vocabulary. This is evident across the school from EYFS to Y6.

3	<p>Use of maths skills and knowledge across the maths curriculum and wider subject areas.</p> <p>Assessments and monitoring indicate that some children find applying mathematical knowledge in a range of contexts challenging and that this, coupled with limited resilience, prevents them from fully developing their problem-solving skills in maths.</p>
4	<p>Emotional wellbeing - often presenting as anxiety and impacting on resilience and engagement with more challenging work.</p> <p>We have seen an increase in the number of pupils struggling with their emotional wellbeing in school as well as at home. This has been seen by staff and through discussions with families. Some pupils are struggling with low self-esteem and not being able to self-regulate.</p>
5	<p>Limited cultural capital limits life experiences and engagement with the wider curriculum.</p> <p>Monitoring indicates that children have had less exposure to wider 'life' experiences, partly due to Covid-19 and now compounded by the current cost of living crisis. This impacts on the wellbeing of the child and their engagement with the wider school curriculum.</p>
6	<p>Some lower attendance than in previous years alongside children arriving late to school, missing the beginning part of the day.</p> <p>Monitoring shows that attendance rates have dropped from those in previous years and an increased number of pupils are arriving at school late in the morning. This is impacting on their learning during the first part of the day as well as overall attendance affecting their academic progress.</p>
7	<p>Independent writing skills.</p> <p>Outcomes and monitoring show that pupils are not always transferring their learned writing skills independently, both transcription and composition.</p>

Part B: Review of the previous academic year

Outcomes for disadvantaged pupils

There have been many successes over the past year, especially in terms of pupil outcomes and strategies to support mental health and wellbeing.

The additional ELSA hours have been invaluable at supporting many pupils, including those who are disadvantaged. The ongoing training for the therapy dog and introduction of Pony Therapy is adding significantly to our 'toolkit' of support strategies for many children.

We have continued to see an improvement in terms of school-readiness with effective support for those pupils who struggle to come into school in the morning. This bespoke support has been adapted and refined as time has gone on to ensure that the changing needs of the children are reflected in the strategies being used.

Attendance information shows an improving picture across the board with the gap closing between disadvantaged pupils and their peers. Attendance overall for 23/24 was 94.5% with attendance for disadvantaged pupils being 91.6%. Although there is difference, this is accounted for due to specific circumstances. Attendance data for the past 12 months showed 95.6% compared to 93.1% for disadvantaged pupils and data for 24/25 to date shows 96.1% compared to 93.5% for disadvantaged pupils (2.9%, 2.5%, 2.6% differences respectively). This continues to be an area of focus.

We have analysed the performance of all disadvantaged pupils across the school using outcomes from EYFS, phonic screening check outcomes, KS1 and KS2 end of key stage outcomes and our in-school data for all other year groups.

We have looked at our outcomes against those of previous years as well as against national and local data. We have treated some of the data with caution as there are small numbers of disadvantaged pupils in some year groups and some year groups with high levels of SEND need (either EHCP or SEND support).

Pupils currently in the school are mainly on track to achieve the expectation in reading, writing and maths, except for a small number of pupils, or to make good progress from their starting point. There are effective interventions and additional support in place for these pupils to ensure their attainment and progress.

We have strong means of identification in place ensuring that interventions are timely, appropriate and bespoke to the needs of individual or groups of children. The impact of CPD is ensuring staff are skilled at meeting the needs of all pupils.

100% of disadvantaged pupils in EYFS achieved a good level of development.

Attainment data at the end of 23/24 showed the following gaps between disadvantaged pupils and their peers at the end of KS2.

Headline figures for the cohort were 71% for reading, 74% for writing, 76% for GPS and 69% for maths. This compared to 67% for reading, 73% for writing, 67% for GPS and 47% for maths for disadvantaged pupils. Compared to non-disadvantaged pupils the following gaps exist: reading -5%, writing -2%, GPS -12%, maths -28%.

The same data for 22/23 showed gaps of 31% for reading, 27% for writing, 37% for GPS and 47% for maths.

This shows an improving picture and a reduced gap in all subjects between disadvantaged pupils and their peers by the time the children leave in Y6.

The implementation of Little Wandle Letters and Sounds continues to see improved phonics provision. This was seen in improved outcomes for pupils leaving EYFS and for those currently in Y1/2 who achieved well.

The continued use of TT Rockstars to support with multiplication tables knowledge has again supported strong outcomes in the Multiplication Tables Check for Y4 pupils.

A continued focus on curriculum development has ensured that we have a curriculum which is fit for purpose, builds on prior learning and gives all children the knowledge and skills they require. Subject leaders have ensured that pupils have a voice in designing and refining the curriculum. Curriculum leaders have ensured there are curriculum 'enhancements' such as visits, visitors into school etc, to increase pupils' 'cultural capital' and knowledge. As a result of this, pupils are engaged in learning and enjoy their lessons and are accessing a range of extra-curricular activities.

The ongoing focus on the further development of arts subjects is having a positive impact on pupils across the school with the percentage of disadvantaged pupils participating increasing each year.

High quality teaching is in place across the school. This is based on an entitlement for all children of high quality provision with appropriate intervention and support where a need is identified.

Interventions and support for pupils with emotional wellbeing are embedded across the school and staff are adept at identifying and providing support in line with pupils' needs.

At present, we are on track to meet the aims of this multi-year plan and have identified a continued focus on maths and attendance as two prime areas for focus this year.
